
Manufacture And Install Two (2) Non-Illuminated Blade Signs

- Signs to be fabricated using 1 1/2" Aluminum square tubing for frame.
- Frame to be powder coated Satin Black.
- Sign face to be oversized and cut from 1"8" aluminum.
- Finish to match brand standards.
- Apply 3M Matte Black vinyl to first surface.
- Sign to hang (Minimum 9' H.T.G.)
- Mounting detail to follow field survey.

 3" = 1'-0"



Proposed Sign Locations


